The Region's fund balance on 05/28/2024 was \$674,490.54. Moser read her letter of resignation as fiscal agent as of June 30, 2025. The board consensus was to accept it as part of the upcoming transition in FY25.

Old Business

FY23 Ending Fund Balance Update – Motion by Merrill and seconded by Jensvold to approve the FY23 new ending fund balance and submit it to HHS. Motion was unanimously approved.

Legislative Update and CCNIA Planning and Consultation – Loehr gave an update on HF2673. The bill was signed by the Governor on May 15, 2024. Transition plan will be published July 1, 2024. Loehr would like to use Open Minds Consultation Group during the transition. No action was taken.

New Business

FY25 Contract – Turning Point Crisis Residential contract – Motion by Schmidt and seconded by Davis to approve the contract with Turning Point for FY25. The motion was unanimously approved.

Exception to Policy-Prairie Ridge IHH Care Coordinator – Motion by Jensvold and seconded by Vanderveen to approve the Exception to Policy for additional utility assistance for a Duncan Heights client for June through September 2024. The motion was unanimously approved.

Exception to Policy-UnityPoint – Motion by Nath and seconded by Davis to approve the Exception to Policy to pay approximately \$2,500.00 for Low Intensity CSP/Access fees to Berry Hill/UnityPoint. The motion was unanimously approved.

Palo Alto Hospital Behavioral Health Presentation – Abby Burns – Burns reviewed the use of the impact grant that PACH had received and how the money received was used.

Lutheran Services of Iowa Impact Grant – Motion by Jensvold and seconded by Schmidt to approve the extension of the LSI impact grant reporting from 6/30/24 to 12/31/24. Motion was approved. Davis abstained.

Financial Projection and Projects – No action was taken. The board advised Loehr to research options.
