July 1st, 3 new services added to spreadsheets: Subacute, Access Center Intake and Assessment, IRSH.

Eastern 3 counties-working with NIACOG for transportation for clients to have greater access to mental health and disability services.

Embrace Health therapy services for inmates, working on establishing smooth access.

40 Hour CIT is December 9-13, 2024 at the Palo Alto Law Enforcement Center. Registration has gone out, and is due November 1st. A maximum of 20 law enforcement officers are accepted.

Regional Updates- Melissa Loehr/ Jenn Dykshoorn

Loehr:

There were 80 plus participants from 50 plus groups at the community flood meetings.

Mobile Crisis served the community with flood stress. Seasons was available to the public.

The community is in the long-term recovery phase of the flood. There has been strategic, broad, and specific planning.

Seasons is seeing use of services post-flood.

Pride Group and Avera contracts are pending.

Avera physicians are not wanting to testify. CCNIA continues to work with them to find a work-around.

Avera billing by code / diagnosis. They want to guarantee region will pay if the patient has extended stay.

Fiscal Agent, Carmen Moser, is resigning from Fiscal duties at the end of FY 25. Loehr is looking at possibilities for replacing her.

The new Mental Health District map has been issued. Letters of intent to apply for ASO are due 9/18/24.

ASOs should be awarded by December 31, 2024.

Seasons Center is getting ready to open the Crisis Center by the end of October. They are waiting on 1 more hire / employee.

FY 24 Mobile Crisis usage and data charts were reviewed.
