Special Project Requests – Seasons-ASSIST training, Kossuth Liaison-training conference/travel – Motion by Jensvold and seconded by Miller to approve a Special Funding Request for Seasons ASSIST training in the amount of \$3,598.15. Motion was unanimously approved.

Motion by Schmidt and seconded by Davis to approve a Special Funding Request for Kossuth Liaison training conference/travel in the amount of \$3,120.00. Motion was unanimously approved.
